#### 8. EXPOSURE CONTROLS / PERSONAL PROTECTION

**Ventilation** Do not inhale vapours. Use in well ventilated areas. #### **12. ECOLOGICAL INFORMATION**

**Environment** Aliphatic hydrocarbons behave differently in the environment depending on their size. WATER: Light aliphatics volatilise rapidly from water (half life - few hours). WORK PRACTICES - SOLVENTS: Organic solvents may present both a health and flammability hazard. It is recommended that engineering controls should be adopted to reduce exposure where practicable (for example, if using indoors, ensure explosion proof extraction ventilation is available). Flammable or combustible liquids with explosive limits have the potential for ignition from static discharge.
